Voluntary Peer Review of Competition Law and Policy: Malawi

Thursday, 8 July 2021 (15:00 - 18:00)

The purpose of this voluntary peer review exercise is to assess the competition legal framework and enforcement experience of Malawi, which adopted its competition regime in 1997-1998, and established a fully-fledged competition authority, in 2013. Furthermore, it seeks to identify areas for improvement of the legal and institutional framework thereby contributing to enhancing the quality, efficiency and effectiveness of competition law and policy in the country.

The expert report drafted will serve as a basis for the peer review examination during the 19th session of the Intergovernmental Group of Experts on Competition Law and Policy (IGE). The review panel will include representatives of the competition authorities of South Africa, Zambia, and a Competition Expert from the United States. In addition, speakers from the floor will have an opportunity to contribute to the discussion.

The peer review will provide Competition and Fair Trading Commission (CFTC) with an invaluable opportunity to draw lessons from the experiences of other competition authorities in competition law and policy. UNCTAD used the findings and policy recommendations of the peer review report in designing a tailor-made technical assistance project to strengthen the competition regime in Malawi. UNCTAD wishes to invite development partners and donors to support this project, which will be presented during the session.
