# Regionalism in a time of uncertainty

#### **Description**

Multilateral negotiations face increasing fragmentation driven by geopolitical tensions and the rise of unilateral trade-restrictive challenging measures. In this environment, regional and megaregional initiatives offer a pragmatic and flexible alternative, particularly for countries seeking to maintain momentum on trade liberalization and economic cooperation. Originally complementary to multilateralism, regional trade agreements provide dynamic platforms for cooperation among geographically and economically like-minded countries. They can contribute to expanding markets, attracting investment, creating jobs and fostering inclusive development. The long-standing support of UNCTAD for regional integration, including through initiatives such as the African Continental Free Trade Area Agreement, the Association of Southeast Asian Nations and the Global System of Trade Preferences, continues to be instrumental in advancing on this path.

Discussions at this round table will explore how open regionalism can respond to the present trade challenges through offering the predictability and certainty needed for sustainable economic growth. To guide the future work of UNCTAD on harnessing regionalism for development, discussions will draw on diverse regional experiences, distil key lessons learned and examine how integration efforts can respond to emerging priorities such as the digital economy and environmental sustainability, while complementing and reinforcing multilateral initiatives.
