Creating synergies with UNCTAD-HMRC-WCO capacity building program on trade facilitation, the second round of national trainings will be held between May and July 2016 and will count on a wide range of experts from UNCTAD, UNIDO, WCO and the EAC. The workshops aim to follow up on the functioning of the NTFCs and improve the technical knowledge of members on selected TFA measures.
