Legal assessment of the competition rules of Belarus and of the regional competition rules of Eurasian Economic Union (EAEU)

In 2018, the Ministry of Antimonopoly Regulation and Trade of the Republic of Belarus (MART) requested the UNCTAD Secretariat to undertake a legal assessment of Belarus' competition law dated 12 December 2013 (i.e. comments of its law provision-by-provision) based on the UNCTAD Model Law on Competition and international best practices on competition law and policy from jurisdictions of developing countries and countries with economies in transition

Similarly, the Eurasian Economic Commission (EEC) requested the UNCTAD Secretariat to undertake an expert assessment of their EEC competition regulations based on the UNCTAD Model Law on Competition and the international best practices on competition law and policy from jurisdictions of developing countries and countries in transition.

The UNCTAD Secretariat has carried out numerous assessments of draft competition bills as part of its advisory services and technical assistance work with different UN member States from developing countries and countries with economies in transition.

Bearing in mind the above, the UNCTAD Secretariat drafted two opinions whose terms were agreed with the requesting parties. The assessments focus uniquely on the legal Competition framework and implementing regulations as appropriate, neither the institutional framework nor the enforcement practice and case law and no other peers were addressed in this exercise.

These assessments provide recommendations that may improve the enforcement of the Competition Law in Belarus and of the regional competition regulations in the Eurasian region.
